Letter of Comfort

Received relevant induction and training in safeguarding including Prevent Training; FGM and E-safety training. That they have read and understood how to apply Part 1 of Keeping Children Safe in Education 2022; are aware of the organisations' whistle blowing procedure and are clear on when and how to make a safeguarding referral.

Reporting Attendance & Progress

We report attendance via email at 10am and 2pm each day. Any reasons for absence provided will be recorded on our system and subsequently communicated to you by phone or email. For those young people that are dual registered, attendance data can be reported to both schools.

When recording attendance, we include lateness by the minute, so that progress and improvements can be quantified. We also use LABS tracking to monitor progress both socially and academically for each session attended. This data is included as part of an end of term report but can also be provided upon request. The end of term report will reflect on goals set as part of the individual learning plan.





Information Sharing

Information sharing - Advice for practitioners providing safeguarding services to children, young people, parents, and carers July 2018

Sharing information is an intrinsic part of any frontline practitioners' job when working with children and young people. Information sharing helps to ensure that an individual receives the right services at the right time and prevents a need from becoming more acute and difficult to meet.

Poor or non-existent information sharing is a factor repeatedly identified as an issue in Serious Case Reviews (SCRs) carried out following the death of or serious injury to, a child. In some situations, sharing information can be the difference between life and death.

Fears about sharing information cannot be allowed to stand in the way of the need to safeguard and promote the welfare of children at risk of abuse or neglect. Every practitioner must take responsibility for sharing the information they hold and cannot assume that someone else will pass on information, which may be critical to keeping a child safe.

The Referral Process

A referral can be made at any time, securely, via our website. If you do not have a partnership agreement or signed service level agreement in place, we'll send this across for signing by a member of the senior leadership team or headteacher. If this is already in place, they'll be nothing more to do until we approve the placement and make contact to confirm arrangements for an initial visit.
